

INVESTMENTS – ARM PROJECT UPDATE




- Project delivery ended up slipping considerably towards the main construction end point, through a combination of snagging issues of contractor / equipment availability.
- HSE a total of 5 minor injuries throughout with an instance of contaminated ground, this was hydrocarbon contamination which was isolated and disposed of via contaminated waste routes.
- Construction works are essentially complete, the next phase until the end of the year will be commissioning and full discharge of planning permissions
- Biodiversity enhancements are scheduled for completion during November with a works team pride day to carry out the planting at the front of the building. Considerable effort has expended on ensuring most of the tree planting survived during the drought conditions experienced over the summer.

- The share holder agreement has been signed and created Peak Cluster Limited
- National Wealth fund has provided £28.6m of £59.6m for the next phase of the project
- The project is aiming to decarbonise 40% of the UK Cement and Lime industry in a single project
- Both the onsite and pipeline designs now begin at pace

Solar Farm - Site Layout (proposed)



- Detailed biodiversity work has been carried to determine the maximum size of the array
- A number of developers will offer design and delivery options
- Several funding models have been identified & are yet to be determined
- The solar project will be included within the consultation in September also covering the limestone quarry extension application.

HOPE WORKS: SAFETY & ENVIRONMENT



Environment

- Since the last meeting part A notifications have been made to the environment agency for:
 - Kiln 2 Dioxin & Furan exceedance 15th July 2025
 - Kiln 1 Sulphur Dioxide exceedance 11th June 2025
 - EA belt filter dust exceedance 18th July 2025
 - Kiln 1 Nitrogen Dioxide exceedance 25th August 2025
- The dioxin and furan investigations continue with the following key points:
 - We have lowered the bag filter inlet temperature from 285 to 260 degC which has enabled us to achieve compliant emissions results.
 - Increased sampling has been carried out around our wider gas circuit to identify points of formation; we are working with Patrick Dyke who is a recognised expert in the field.
 - A carbon sorbent trail has been carried out during August, we are awaiting the results, our hope is that carbon sorbents will provide an alternative lever to assist temperature control to enable consistent and long-term compliance.

HOPE WORKS: PLANT PERFORMANCE & SHUTDOWNS



- Kiln Performance:
 - Average Reliability Factor 97.67% YTD (95.34% for 2024)
- Major Repairs:
 - Kiln 1 shutdown was completed on time in January 2025.
 - Kiln 2 shutdown has commenced and is scheduled to last until 8th October 2025.



- Even more exciting, this allowed us to ring our first chicks on site, contributing valuable data to national conservation efforts.

We also had lots of entertainment including Circus Workshops and Face Painters.










ROAD MOVEMENTS: 2025 DATA YTD




ROAD MOVEMENT TIMINGS



INCOMING DATA AVERAGED PLUS TYPICAL CEMENT OUTWARD


Hope Works Average Hourly HGV Movements June 2025 - August 2025
